Lisa asked me to check out a 501 © (3) belonging to LOCSD Director Gordon Hensley. He has a web site that has been under construction for almost 2 years. I believe I sent you that information.

Now on to Gordon (Hensley). I have been searching the files as you know, and Gordon's travel vouchers and credit card statements for this fiscal **July-now 04-05** year are missing - everybody else has one, even Julie and I have a file and I have been there only 3 months.

I have asked Bruce (Buel) in writing at least **10** times to look around and get them to me - he says there are none to get, but I don't believe him - I think Gordon took his file - because I have Stan (GUSTAFSON ... CURRENT CSD PRESIDENT) or Rose's (BOWKER ... PAST CSD PRESIDENT) **secret appointment** of Gordon to the Coastal Commission on the CSD agenda to discuss in public, and because we believe that CSD may be in collusion with COASTAL COMMISSION about the permit, and because the community has a lot of private money and time now tied up in the lawsuit and revocation and repaying consultants for mistakes that have been made, I believe they have a right to know what he has been doing and charging for (but he didn't show up for that meeting, so I postponed it).

Gordon (Hensley) has been going to Coastal Commission meetings on the citizen and CSD'S dime for over three **3** years. He stays in the best hotels, flies, pays for big meals for Commissioners and he also conducts his own business (either 501c3 business or consulting business) while he is at these meetings, held round the state.

I have found all of this from pushing through **emails** and from his **past credit card receipts** (which are there for the pasts five years **but not for 2004/ 05**), so I am now supposed to believe that for this year there are none?

I saw him in Sacramento and San Pedro myself. I know he went to Washington DC, Monterey, and more, so why no receipts? Bruce (BUEL ... GM) said he (Hensley) didn't charge, but if not, why not? (that is why I want to find out about his 501c3).

So I keep pushing, but last night (Tuesday), Bruce (Buel) told me I was "**unprofessional**" for continuing to ask and then he told me he absolutely refused to even call the credit card company and order copies of his statements because "**it would take too much time**" and now (GEORGE)

Milanes (A CSD EMPLOYEE) is threatening to sue me for a meeting I conducted - its getting worse for me, I must be getting close....
