

Seven Reasons for the Recall

It's more than the Sewer..... It's about Bad Government

Social Justice & Unfair Treatment of Citizens of Los Osos

- # The sewer places an unfair financial burden on both renters and owners in the Prohibition Zone
- # The sewer requires a few to pay for cleaning up all of the groundwater in the Los Osos Basin and for the park at the sewer plant too

Divided Our Community

- # CSD lied about the cost, the "buried" plant and the real reasons for building in-town
- # Sided with the State Water Resources Control Board to threaten us with fines if we don't allow the CSD to build this project in their location
- # Won't allow the community their legal right to choose a cheaper alternative when all sewer options cost less out of town
- # CSD lied about fines.

High Costs: Sewer Now up to \$225 per month ... and rising

- # Unaffordable and will hurt our families
- # Will force many families and friends to move
- # Our children and Grandchildren won't be able to live here
- # Many will be forced to choose to pay the sewer bill or pay for medicine and food
- # We can lose our homes if we don't pay

CSD Lied to the community about the Sewer Project

- # SWRCB confirmed, "It was never the Water Board that told them where or what to build"
- # The Time Schedule for Enforcement was developed by Bruce Buel, not the RWQCB
- # Deferred parts of the project to build later and will cost us even more
- # Sewer will not clean and protect our water
- # CSD Promised Grants and delivered a huge unaffordable loan... and our homes are collateral!

Out of Control Spending

- # RCSD refused an independent audit of the books. Why not?
- # CSD tried to pass the excessive Fire tax, only with our vote did we stop more wasteful, irresponsible spending
- # CSD has spent thousands of dollars on slick PR to sell the unwanted sewer location
- # High Salaries and Benefits with Special Pay Raises, cars, gas & credit cards for selected CSD employees
- # Sole source contracts and sweetheart deals for CSD Associates and Friends
- # Expensive Trips to Washington DC: Millions in wasted lobby \$\$\$

All Charges for Services Have Increased Dramatically Since CSD Took Over

- # Check your Water Bill, Trash Bills, and any others for the increases
- # There is more planned!! I Nearly \$20 mil in deferred sewer costs
- # Surprise! 90% of water connection must be replaced...YOU PAY THE BILL
- # Any conservation will result in higher water rates... (B. Buel)
- # This is just the first installment on massive and wasteful CSD projects

Refusal to Listen Community

- # About Affordability- Won't Allow Alternative Project Discussion
- # About Health and Safety- Not Allowed to Vote on Location
- # About Bringing us together- Board Members won't listen to New Board Members
- # About Fairness – The CSD 3 will not allow Director Shicker access to the accounting records
- # About Being Civil- Board Members Verbally Attack Citizens...assaults reported to law enforcement reveal all were perpetrated by Pandora Nash Karner and her "Save The Dream" organization
