

# THE CALIFORNIA COASTAL COMMISSION and THE LOS OSOS WASTEWATER PROJECT

**The mission of the Coastal Commission is to: “Protect, conserve, restore, and enhance environmental and human-based resources of the California coast and ocean for environmentally sustainable and prudent use by current and future generations.”**

**Protect:** “To cover or shield from that which would injure, destroy or detrimentally affect.”

A central sewer will destroy our environment; our way of life and endanger the health of all Los Osos residents.

**Conserve:** “To keep in a safe, sound state; to preserve from change or destruction.”

A central sewer will NOT conserve, preserve or protect our water or environment. It will destroy it!

**Restore:** “To give back something which has been lost or taken away: To renew; to re-establish; to bring back.”

If there is NO central sewer there will be nothing to “restore.”

**Enhance:** “To raise: to lift: to exalt. To advance, augment or elevate.”

A central sewer does nothing to “enhance” our environment, way of life, or protect our health.

**Prudent:** “Capable or directing oneself wisely and judicially; morally or intellectually disciplined.”

The “prudent” act is to deny ANY permit for this fraudulent, vaccine-resistant deadly pathogen-producing factory.

The California Coastal Commission is made up of 12 appointed-for-life-individuals. These 12 people hold the future of Los Osos in their hands and in their votes. If they all do their job objectively, relying only on facts and truth with a commitment to justice and Freedom, Los Osos will be saved from the terrorist sewer nightmare.

With the exception of SLO County Supervisor Khatchik Achadjian, who is obviously in the pocket of the county corruption (and should resign from the Commission), the adherence by the remaining 11 Commissioners to the fairness/truth/Freedom equation is yet unknown.
